

TERMS & CONDITIONS

Kenya Diaspora Connect UK

These Terms & Conditions govern your use of the Kenya Diaspora Connect UK website, network, events and related services.

1. About Us

Kenya Diaspora Connect UK ("KDC") is a trading name of Intraworld Ltd, a company incorporated in the United Kingdom.

Intraworld Ltd operates Kenya Diaspora Connect UK as a platform connecting Kenyans living in the United Kingdom with organisations, businesses, institutions, community groups, events and opportunities in the UK and Kenya.

In these Terms, references to **"Kenya Diaspora Connect", "KDC", "we", "us" or "our"** mean Intraworld Ltd trading as Kenya Diaspora Connect UK.

By accessing our website, joining the KDC network, registering for an event or using our services, you agree to these Terms & Conditions.

2. Our Services

KDC provides services designed to strengthen connections between the Kenyan diaspora in the UK and organisations seeking to engage with this community.

Our activities may include:

- virtual events and webinars;
- conferences and physical or hybrid experiences;
- diaspora engagement programmes;
- networking and community activities;
- community partnerships;
- information about relevant opportunities, events and initiatives; and
- related engagement and communications services.

Our services may evolve as KDC develops.

3. Using the Platform

You may use KDC to discover and register for events, join the KDC network, participate in virtual and physical activities, receive information about relevant opportunities and connect with participating organisations and communities.

When providing information to us, you agree that it will be accurate and that you will not knowingly provide false or misleading information.

You must not use our website, network or events for unlawful, fraudulent, abusive or harmful purposes.

4. Events

Events promoted through KDC may be:

KDC events — organised directly by Intraworld Ltd trading as Kenya Diaspora Connect;

Partner events — organised jointly with another organisation; or

Third-party events — promoted or facilitated by KDC but organised by another organisation.

The relevant event page will normally identify the organiser and provide information about dates, times, venues, speakers, prices where applicable, registration requirements and participation arrangements.

We may use third-party technology platforms to administer registrations or deliver events.

Where an event is provided by another organisation, additional terms or privacy arrangements of that organisation may apply.

5. Event Changes and Cancellations

KDC and its event partners may make reasonable changes to event programmes, speakers, venues, dates, timings or delivery formats where circumstances require.

Registered participants will be informed of material changes using the contact information provided during registration.

Where an event requires payment, the applicable cancellation and refund conditions will be provided during the booking process.

Nothing in these Terms affects statutory consumer rights that cannot lawfully be excluded.

6. Virtual Events

Participants in virtual events are responsible for having suitable internet access, equipment and software.

Event access links are intended for registered participants and should not be shared unless permission has been given.

KDC may remove participants who behave abusively, unlawfully or disruptively or who interfere with the reasonable enjoyment of an event by others.

7. Photography, Video and Recording

Physical and virtual events may sometimes be photographed, filmed or recorded.

Where this occurs, we will provide appropriate notice and obtain additional consent where required.

Images and recordings may be used for event reporting, communications, promotional activities and other legitimate KDC purposes in accordance with our Privacy Policy and applicable data-protection law.

8. Partners and Third-Party Organisations

KDC may work with Kenyan and UK businesses, financial institutions, professional bodies, community organisations, educational institutions, public bodies and other organisations.

The presence of an organisation, opportunity, product or service on KDC does **not automatically constitute an endorsement or guarantee by Intraworld Ltd or KDC**.

Unless expressly stated otherwise, KDC is not the provider of products or services offered by third-party organisations.

Users should make their own assessment before entering into financial, investment, commercial or other arrangements with third parties.

This provision will be particularly useful as KDC begins hosting banks, SACCOs, property companies and investment-related organisations.

9. Financial and Investment Information

KDC may host events or publish information concerning savings, property, investments, financial services, business opportunities and related subjects.

Unless expressly stated otherwise, **KDC and Intraworld Ltd do not provide financial, investment, tax or legal advice**.

Information presented by participating organisations or speakers represents their own information or views.

Users should obtain appropriate independent professional advice before making significant financial or investment decisions.

This separation is important because using a trading name does not itself confer any regulatory status or permission to undertake regulated financial activities.

10. Community Standards

KDC is intended to provide a professional, inclusive and respectful environment.

Participants must not use KDC to:

- harass, threaten or discriminate against others;
- distribute unlawful or harmful material;
- impersonate another person or organisation;
- collect or misuse other participants' personal information;
- promote fraudulent or deliberately misleading opportunities; or
- interfere with the operation of our website or events.

We may suspend or terminate participation where these standards are seriously breached.

11. Intellectual Property

Unless otherwise stated, the KDC name, branding, website design, original content, graphics and materials produced for the platform are owned by **Intraworld Ltd** or used by Intraworld Ltd with permission.

Names, logos, trademarks and materials belonging to participating organisations remain the property of their respective owners.

KDC content may not be copied, reproduced, republished or commercially exploited without permission except where permitted by law.

12. Third-Party Websites and Services

Our website may contain links to websites, registration systems, payment services, video-conferencing platforms and other services operated by third parties.

These services are governed by their own terms and privacy policies.

KDC is not responsible for the operation or content of independent third-party websites or services.

13. Availability

We aim to keep KDC's website and services available and accurate but cannot guarantee uninterrupted or error-free operation.

We may update, modify, suspend or withdraw elements of the platform where reasonably necessary.

14. Liability

Nothing in these Terms excludes or limits Intraworld Ltd's liability where it would be unlawful to do so.

To the extent permitted by law, Intraworld Ltd is not responsible for losses resulting from reliance solely upon information provided by independent third parties or for products and services independently provided by partner organisations.

15. Privacy and Personal Information

Intraworld Ltd is responsible for personal information collected directly through KDC where Intraworld Ltd acts as the data controller.

Our collection and use of personal information is explained in the **KDC Privacy Policy**.

Where another organisation separately collects or controls your information, its own privacy policy may also apply.

16. Changes to These Terms

Intraworld Ltd may update these Terms as KDC's services develop or to reflect legal, regulatory or operational changes.

The current version will be published on the KDC website together with the date it was last updated.

17. Governing Law

These Terms are governed by the laws of **England and Wales**.

The courts of England and Wales will have jurisdiction over disputes arising from these Terms, subject to any mandatory rights available to consumers in other jurisdictions.
